To Our Valued Participants:

At Jefferson County Public Schools (JCPS), we are committed to offering our participants a broad and diverse array of quality investment options. With that in mind, on behalf of the JCPS TSA/403 (b) Plan, I am pleased to announce exciting enhancements to the JCPS TSA/403 (b) Plan's investment option choices.

On August 3, 2006, six new investment options will be added to the Plan: Hotchkis Wiley Large Cap Value, American Funds Growth Fund of America R4, Artisan Mid Cap Value, Munder Mid Cap Core Growth Y, Veracity Small Cap Value, and TCM Small Cap Growth.

In addition, after careful review the JCPS TSA/403 (b) Plan has decided to discontinue seven investment options effective August 3, 2006: American Funds Washington Mutual Investors R4, American Century Ultra Investors, American Century Equity Income, Calamos Growth Fund A, Goldman Sachs Mid Cap Value A, Constellation Clover Small Cap Value, and Baron Small Cap Fund. These funds are being discontinued because their long-term performance no longer meets the criteria established in the JCPS TSA/403 (b) Plan's investment strategy. As a reminder, the JCPS TSA/403 (b) Plan's investment options closely mirror the State of Colorado 457 Plan's investment options are reviewed by the 457 Plan's Committee and an outside investment adviser.

Seven Discontinued Investment Options

Effective August 3, 2006, seven investment options will be discontinued, and a process called "mapping" will occur. After market close on Thursday, August 3, 2006 through Friday, August 4, 2006, no participant transactions will be allowed. During this period, future contributions and existing account balances in these discontinued investment options will be directed or "mapped" to the replacement investment option indicated in the chart below:

Call KeyTalk® at **(800) 701-8255 (English)** or **(888) 935-4652 (Spanish)**.² You will be prompted to enter your Social Security Number and Personal Identification Number (PIN). If you have misplaced or forgotten your PIN, press "1#" to order a PIN.³

PRESS 3 to access the "Change Your Account" menu, then

PRESS 1 to redirect your ongoing contributions to one or more of the existing options, or

PRESS 3 to transfer money between investment options

Web site Instructions for Investing in Your New Options

To make changes online, access the Web site at www.jeffcoschoolsgwest.com.² You will need your PIN³ and Username to access your account and make changes.

Click on "Change Account" from the top menu, then

Click on "Current Allocation" to redirect your ongoing contributions, or

Click on **"Fund to Fund Transfer"** to transfer money between investment options

Reality InvestingSM

As a result of the fund changes, you will be temporarily unable to access the Reality Investing service while Ibbotson Associates analyzes the Plans' new investment option lineup and implements these changes on your account. The inaccessibility period for the elimination of funds will begin August 3, 2006 and last for approximately 10 business days. An error message will appear if you enter the Reality Investing section of the Web site during this time. You will still be able to view your account balance.
